## **CALL TO ORDER-PUBLIC HEARING:**

Mayor Leeming called the Public Hearing to order at 7:13 pm to receive comments on the fiscal year 2023-2024 Budget for all City funds, the DDA Budget, the Six-Year Capital Improvement Plan, and the millage rate of 13.00 mills for general operations.

Hearing no comments, written or verbal, Mayor Leeming closed the Public Hearing at 7:14 pm

## **OLD BUSINESS:**

None

## **NEW BUSINESS:**

1. Award Three-Year Auditing Contract to Maner-Costerisan:

Maner-Costerisan Certified Public Accountants has provided the City of DeWitt with a proposal for a three-year contract for auditing services for the fiscal years of June 30, 2023. 2024 and 2025. Maner-Costerisan has been with the City of DeWitt, DDA, and DAESA since 2018 providing auditing services. In addition to performing the City of DeWitt audit each August, they complete the DDA and DAESA audit while on-site. The DDA and DAESA are billed separately for their audit costs. Maner-Costerisan has conducted itself in a very professional manner and completed an extensive review of our financial statements for all government functions. They are proposing the following fee structure:

FY2023 - \$18,500 (includes DDA - \$3,500)

FY2024 - \$21,000 (includes DDA - \$4,000)

FY2025 - \$23,600 (includes DDA - \$4,500)

DAESA is considering a three-year extension with Maner-Costerisan at their May 18, 2023, regular meeting.

Rehman CPA & Consultants did receive an RFP to bid on the service but declined to submit a bid. They indicated staffing levels would preclude them from providing a competitive bid to the City of DeWitt.

Motion by Hunsaker, seconded by Donohue carried by unanimous vote of the Council to approve the contract for auditing services with Maner-Costerisan Certified Public Accountants for the fiscal years ending in June 30, 2023, 2024, and 2025 and authorize the Mayor and Clerk to sign the contract on behalf of the City.

## 2. Approval of FY 2023-24 Budget:

A public hearing has been published in the April 28, 2023, *Lansing State Journal* for the public's consideration of the FY 2023-24 Budget, Fee Schedule, Millage Rate, DDA Budget, and Six-Year Capital Improvement Plan per the requirements of PA 2 of 1968 and the DeWitt City Charter

Motion by VanDyke, seconded by Donohue carried by unanimous vote of the Council to approve Resolution #2023-04 adopting the FY2023-2024 Budget and 2023-2028 Capital Improvement Plan, DDA Budget, adopting the FY 2023-2024 Schedule of Fees, and setting FY2023-2024 Millage Rate at 13.0 Mills.

### 3. SCCMUA 2022 Fund Balance:

SCCMUA has provided the City of DeWitt with their December 31, 2022, fiscal year-ending audit, which contains \$20,642.00 in unrestricted funds for disposition in Collection System and \$1,107.00 for the Industrial Pretreatment Program, totaling \$21,749.00.

As discussed during the budget sessions, the city's October 2023 debt payment for the SRF projects is expected to be \$23,428.00. This amount was not included in the city's 2023 budget for SCCMUA due to the uncertainty of when the bond closing would actually happen.

Due to the debt payment not being included in the 2023 Budget, the recommendation is to keep the \$21,749 at SCCMUA and reserve an additional \$1,680.00 from the city's unrestricted reserves to cover the October 2023 debt payment.

If approved, this would leave a balance of \$423,781 in the Collection System reserve account.

Motion by Kellogg, seconded by Donohue carried by unanimous vote of the Council to authorize keeping \$21,749.00 in 2022 unrestricted funds at SCCMUA and to further reserve the funds for the October 2023 SRF debt payment, in addition to reserving \$1,680.00 from the city's existing Collection System reserves to cover the total debt payment of \$23,428.00.

## 4. Distribution of Draft Master Plan:

The Planning Commission has formally completed its review of the Comprehensive Master Plan for the City of DeWitt. The commission, at their regular meeting on April 27, 2023, passed a motion to forward the draft plan to City Council with a recommendation for distribution.

The MI Planning Enable Act (MPEA) requires City Council to approve the distribution of the draft plan for a 63-day public review/comment period. Attached is an outline of the process to approve a master plan per the requirements of the MPEA, developed by our planners Beckett & Raeder, Inc. (BRI). The plan is currently on Steps 3-5.

City Council was provided with a copy of the draft plan for their review. If the council approves the distribution of the plan the plan would be advertised for 63 days to receive public comments.

As a part of the comment period the plan will be distributed to adjacent municipalities, all public utilities operating in the City of DeWitt, and the Downtown Development Authority.

At the completion of the comment period, the Planning Commission will hold a public hearing on the plan and take formal action on the plan.

City Council has the option of passing a resolution to require the Planning Commission to submit the plan to the City Council for final adoption. If the council would like that to be a part of the adoption process a resolution can be prepared for the May 22 meeting.

The plan revisions centered on updating the demographics, maps/tables, and the different planning areas throughout the city. With the development of The Woodlands, that planning area was removed from the Master Plan.

Councilmember VanDyke was in attendance to give a brief overview of the process and some of the modifications made to the plan.

Motion by Whitman, seconded by Hunsaker carried by unanimous vote of the Council to approve Resolution #2023-05 approving the distribution of the draft community master plan as recommended by the DeWitt Planning Commission.

## **Downtown New Bench Unveiling**

The unveiling of the new benches will happen at the first Farmer's Market. The DDA, LEAP, and the artist are communicating to pick a different date. The preference is to hold the ceremony on a Tuesday during the Market. Once a date has been selected invites will be sent to City Council.

## **Concerts in the Park**

The DeWitt Chamber of Commerce's first concert in Riverside Park is scheduled for June 15 from 7-9 pm. The first band will be the Exit 86 Band.

## **Memorial Association Building**

The DeWitt Memorial Association (DMA) has indicated they are reviewing a purchase agreement that was submitted for the building by the church that is renting the west side. If a purchase agreement is signed the church will have to go through the Special Land Use process. The DMA did inquire about the City's interest in purchasing the building.

## Riverside/Sports Park Playground Equipment Installation

The installation for the Sports Park has been scheduled to begin on Tuesday, May 23. Once the installers, MRC, finish the Sports Park they are going to move directly to Riverside Park. If all goes smoothly, including the weather, the new playground structures could be open by late July.

### **DNR Spark Grants**

The second round for the Spark Grants opened on May 1, with applications due by June 26. Resolutions of Support will be on the June 12 Council Agenda for our project submittals. The DNR did announce that the 3<sup>rd</sup> round of grants will only be open to "opportunity communities". A list of the opportunity communities is provided in your General Information packet. The City of DeWitt is not an opportunity community and will not be eligible for the 3<sup>rd</sup> round of SPARK grants.

## **Employee Voluntary 457 Pension Plan**

Staff met with MERS of Michigan on Tuesday, May 16 to get information from MERS about their 457 Pension offerings. Positive feedback was received from staff and an interest in moving forward with transitioning away from ICMA to MERS. Additional information is being gathered from MERS and authorization to switch plans does have to be approved by City Council. This is tentatively scheduled to be presented to Council at the June 12 meeting.



SUBJECT: MDOT TEDF Category B Funds Resolution of Support

**FACTS:** The MDOT Category B Transportation Economic Development Funds (TEDF) are intended for communities with less than 10,000 population and is a competitive application process. There is approximately \$3 million available statewide with the maximum award of \$250,000 for each community. The Category B funds have to be matched dollar-for-dollar by the local community and can only be used for road resurfacing and other activities not considered regular/routine maintenance, such as crack sealing. The funds can only be used on streets that are classified as "local" streets.

The application for the City would include resurfacing West Dill, Looking Glass Glen, Pine Ridge, Cedarwood, a portion of DeWitt Drive, West Webb, and crack sealing various locations throughout the City (see below for full list). The proposed project and application will be for \$500,000 with a local match of \$250,000.00.

Applications are due by 5 p.m. on Thursday, June 15, 2023. If awarded, the funding would be available after October 1, 2023.

#### SUBJECT:

Purchase and installation of new Crysteel Dump Box for 2004 International 7400 4x2 dump truck.

### **SCOPE:**

Replace old 6-yard dump box, LED Lights, Tarp System, 10" Sideboards, and Cabshield on 2004 International dump truck.

#### **BACKGROUND:**

The Public Service Department has four (4) diesel 5–6-yard dump trucks. Three of the newer trucks (2012, 2004 & 1998) are primarily used for snow plowing and curbside leaf removal. The oldest of the trucks (1993 Kodiak) is designated as a backup plow truck and leaf/brush-box truck. After 19 years of snow removal and salting work, the 2004 International dump trucks box needs major repair or replacement to be used this upcoming winter. I received three quotes for the purchase and installation of a new 6-yard dumps box and related equipment. Funds are available in the Motor Pool Capital Outlay DPS Fund for this purchase.
